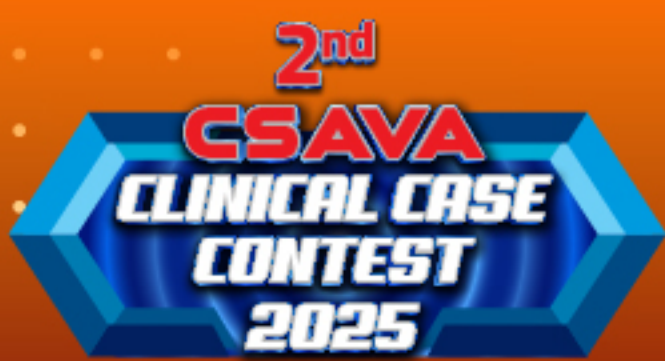

Terms and conditions for CSAVA Clinical Case Contest (CCC) 2025

The CCC 25 competition will be conducted under 4 major categories of clinics with 3 Sub-categories **CANINE - FELINE - AVIAN - EXOTIC & WILD LIFE** species under which 1st, 2nd & 3rd Cash prizes will be awarded separately for each category

1. STAND ALONE – INDIVIDUAL PET PRACTICES & CLINICS

Minimal clinic space 200sq.ft - One registered veterinarian - diagnostic equipments not mandatory - has capacity to treat and provide basic services.

2. MULTI SPECIALITY / CORPORATE - SMALL ANIMAL CLINICS & HOSPITALS

Space of at least 1000sq.ft, has at least one MVSc with experience in specialized area, diagnostics x-ray, USG, Blood analysers, inpatient facilities - Corporate veterinary clinic with referrals.

3. ANIMAL WELFARE ORGANIZATIONS TRUSTS - NGO'S

Any registered animal welfare organization, trust or NGO involved in community animal health on a non-profit basis.

4. VETERINARY COLLEGES – INSTITUTIONAL HOSPITALS & ZOOLOGICAL PARKS

Any VCI approved government/ private Veterinary colleges/ institutions/ small animal hospital with student teaching / faculties / PG students

5. CSAVA - CCC 2025 is open to Small Animal Private Veterinary Practitioners within INDIA only.
6. Participants should possess minimum B.V.Sc degree from a VCI recognized university (proof to be enclosed).
7. Participants should be a registered member with their regional veterinary associations (proof to be enclosed).
8. Each participant can only register Once for ONE case presentation ONLY.
9. The registration fees for CSAVA presenters is Rs.1000/-.
10. The registration fees NON-CSAVA presenters is Rs.5000/- .
11. The delegate shall register online through www.csavachennai.in ONLY.
12. Registration fees need to be paid online and the screen shot of the payment needs to be uploaded.
13. Participants vouch that data supplied on registration are true and complete.
14. The contestants shall expressly accept CSAVA rules on registration and conduct of the events.
15. By registering the User accepts that most communications with CSAVA will take place electronically.
16. There will be no refund/ reimbursement of the registration charges unless or until the
17. case presentation is not selected due to multivarious reasons as decided by the CSAVA board.
18. The presenting author cannot be exchanged at any time after abstract submission.
19. Each participant will be given 8 minutes presentation – 2 minutes discussion with judging panel.
20. All information regarding cases including diagnostics, imaging techniques, therapeutics, clinico pathological examinations need to be authenticated and original and should have been done in their respective clinics ONLY .
21. The clinical cases need to be original without copying, objections and plagiarism.
22. The clinical cases should not have been presented before at CSAVA CCC 2024.
23. The cases should be pertinent to small animals – dogs, cats, Avian & exotics ONLY.
24. Novel ideas, newer concepts, original ideas will be given preferences for the prizes.
25. Delegates to make arrangements on their own for travel and accommodation.
Lunch, Tea / Snacks will be provided.
26. Gala dinner will be complimentary for all the prize winners and chargeable @ Rs.3,500/- for the others.
27. CSAVA board has designated a PANEL OF JUDGES across India with specialization and competence who will assess the CSAVA-CCC 2025 without any bias .
28. CSAVA - CCC 25 - committee has all the discretions to recognize or de recognize categories and sub categories, no of entries, increase or reduce the presentation timings, switch categories, increase or reduce the awards & cash prizes depending on the minimal & maximal entries.
